A MESSAGE FROM THE BOARD ATTORNEY

Updating board rules:

In April, 2003, the board adopted a number of housekeeping revisions to its rules. For the most part, the changes were necessary to make the rules consistent with current board practices, and most architects will hardly notice these updates and revisions.

In addition, however, the board adopted changes concerning emeritus architects and continuing education. These changes are important and should be observed.

Emeritus architects:

The pertinent board rule previously provided that registrants retired from active practice who have either practiced architecture for thirty (30) years or more or who are 65 years of age or older may request emeritus status. The rule did not define "retired from active practice", and there apparently was confusion concerning exactly what that phrase meant. Some architects apparently believed that they were "retired from active practice" if they no longer stamped plans, even though they might otherwise practice architecture. As mentioned in an earlier newsletter, the board did not agree with this interpretation.

To address this confusion, the board has amended this rule. The amended rule provides that "[o]nly a registrant who is fully and completely retired from the practice of architecture may request emeritus status." Further, a registrant "who is either receiving or who anticipates receiving in the future any salary, income, fees, or other compensation (other than retirement income) from an architectural client, architectural firm, architect, design professional, or any other person is ineligible for emeritus status." For the full text, see §1105. E, published on our website.

This amendment will hopefully solve the confusion that has surrounded this issue.

Continuing education:

The rules have long provided that a resident architect must complete a minimum of twelve (12) continuing education hours in HSW (health, safety and welfare) annually. No changes in this requirement have been made. The NCARB Model Rules suggest definitions for "Individually Planned Educational Activities" and "Structured Educational Activities"

In an effort to make the board's rules on continuing education more consistent and compatible with those of other states, the board has added definitions for "Individually Planned Educational Activities" and "Structured Educational Activities". Individually Planned Educational Activities are defined as "educational activities in which the teaching methodology primarily consists of the architect himself/herself addressing HSW subjects which are not systematically presented by others, including authoring a published HSW paper, article or book and successfully completing a college or university sponsored HSW course." Structured Educational Activities are defined as "educational activities in which the teaching methodology consists primarily of the systematic presentation of HSW subjects by qualified individuals or organizations, including HSW monographs, course of HSW study taught in person or by correspondence, organized HSW lectures, HSW presentations or workshops, and other means to which identifiable technical and professional HSW subjects are presented in a planned manner." Of the twelve (12) required CEH, a minimum of eight (8) CEH must be obtained in Structured Educational Activities. No more than four (4) CEH may be obtained in Individually Planned Educational Activities

If you have questions concerning these changes, please review Rule §1315 Continuing Education, which is published on our website.

Satellite offices:

The board rules presently require under "Professional Conduct" that "any office offering architectural services shall have an architect resident and regularly employed in that office." Some other states have the same or a very similar rule; some states have a vastly different rule concerning satellite offices; and some states have no rules concerning satellite offices.

With advances in technology and changes in architectural practice, the board does not presently believe that it would be "unprofessional" to offer architectural services from an office which does not have an architect resident and regularly employed therein, provided a disclosure is made to the client

and certain safeguards are met. The board is in the process of amending its rule concerning satellite offices.

A larger and more diverse board:

Act 231 of 2001 changed the makeup of the licensing board, as well as the method by which the board is appointed. Prior to this Act the board consisted of five (5) architects appointed by the governor. Act 231 added two additional members to the board, one of whom shall be a public member (not engaged in or retired from the professions of architecture, engineering, design, or construction) and the other shall be an educator or regulator member (either employed full time in architectural education or an administrator of building design, construction, or design standards for government), all as more fully set forth in the Act. Governor Foster has recently appointed to the board John E. Cardone, Jr. as the public member and Julian T. White, as the educator or regulatory member. Both are highly qualified. Mr. Cardone currently serves as the City Administrator/Director of Operations for the City of Lake Charles where he oversees and advises various departments governing construction and development. Mr. White is an Associate Professor, College of Art and Design, School of Architecture, Louisiana State University, where he has been employed for more than thirty years.

In addition, the board recently followed the procedures set forth in Act No. 231 to fill the vacancy in District 1 created by the expiration of the term of Raymond G. "Skipper" Post, Jr., after which Governor Foster appointed Knox H. Tumlin to fill the vacancy. Mr. Tumlin currently serves in the Chief Administrative Office of the City of New Orleans, and he has over thirty years experience in project design and management and construction contract administration.

With increased size and diversity, the board trusts that it will be able to continue its goal of safeguarding life, health, and property and promoting the public welfare.



IDP REPORT BY DAVID BRINSON – STATE IDP COORDINATOR

Interns often inquire about their training units and specifically how the community service category figures into the mix of the 700 training units required to complete the program. The [IDP Guidelines](#) place community service in category “D” under the title “Professional and Community Service.” While the “professional” aspect is relatively clear-cut, with membership in AIA, ASAI, ASLA, CSI, etc., some interns are now aware that they cannot earn training units for just attending meetings or conferences. They must be an active member of the organization by volunteering to serve on committees and perform related service activities. They may also become a member of a civic organization. Again, just attending meetings and conferences does not qualify as fulfilling training unit requirements. The intern may participate in civic organizations, neighborhood groups, museum groups and other activities addressing such issues as homelessness, natural disasters, historic preservation, resource conservation and environmental awareness.

Professional and Community Service is defined by the [IDP Guidelines](#) as “any voluntary participation, during internship, in a broad range of professional and community activities. Public service develops and enhances an understanding of the factors that shape society and influence professional knowledge and skills. Public service is not limited to architecturally related activities.” At the completion of the program, the intern should be able to responsibly volunteer in a traditional or non-traditional community based organization to enhance life in the intern’s community. In short, be a good citizen.

The Intern Development Program is not intended to be narrow or restrictive; rather, IDP brings the broad aspects of architectural practice into proper perspective. In addition, new services that do not fall into more traditional practice settings are opening to architects. Other related activities allow interns, while developing basic practice skills, to gain expertise in these areas.

Possible related activities include energy conservation, computer applications, planning, interior design, landscape architecture, environmental and structural engineering, applied research, teaching, historical restoration, and professional delineation. If an intern is amassing a considerable portion of his/her training in related activities, the intern should verify with his/her registration board what the specific jurisdiction requires. Appendix “E” of the [IDP Guidelines](#) describes the NCARB conditions governing IDP training. The Louisiana State Board of Architectural Examiners accepts the basic NCARB criteria as satisfying their pre-requisites for the A.R.E. While experience for credit in other areas is possible, it should be remembered that at some point, training under the direct supervision of a registered architect when the organization’s practice is in the charge of a person practicing as a principal will be necessary.

The IDP is a national program. Practically all jurisdictions accept completion of IDP as satisfying their training requirements.

Maintenance of an IDP record thru the NCARB record keeping process is the only method of satisfying the Louisiana State Board requirements for completion of the program. Other jurisdictions may have additional or varying requirements. Interns intending to become licensed in other states, districts or territories for their initial license should verify the specific requirements with the particular licensing authority. Each jurisdiction has the responsibility of establishing its own individual pre-requisites for licensing.

CONTINUING EDUCATION

The Louisiana State Board of Architectural Examiners believes that Continuing Education has generally been well received, has likely improved the quality of architectural services, and has enhanced the protection of public health, safety and welfare. The Louisiana State Board of Architectural Examiners intends to continue with the program, although some changes are contemplated both in the basic requirements and in the quality of programs and courses.

The Board has concern that some supposedly educational programs are merely sales tools for the provider. The Board will be encouraging continuing education providers to offer high quality generic programs which adhere to industry standards and good educational practices.

As Board members audit the randomly selected transcripts as prescribed in the rules, special attention will be given to the apparent quality level of all courses. Those which appear to possibly be lacking in quality level, or those which appear to be sales tools by a manufacturer's rep, will be scrutinized in greater detail and are subject to rejection as a legitimate learning experience. All Louisiana licensed architects should take care in their selection of courses to be certain each required course is a legitimate learning experience.

The general public and political subdivisions rely on a competent level of performance by all architects. The Louisiana State Board of Architectural Examiners fully intends to uphold a high level of educational programs so that the perceived and actual responsibility of architects to not only maintain, but improve, their commitment to the protection of the health, safety and welfare of the public is a paramount objective for all Louisiana licensed architects.

IMPORTANT REMINDERS

1. To remain licensed in Louisiana, architects are responsible for earning twelve (12) hours of continuing education in Health Safety and Welfare. During the annual audit, architects are chosen randomly and asked to provide proof of CEH's.

2. The Louisiana State Board of Architectural Examiners Law and Rules can now be downloaded from the website. All Active architects and firms are also found on the website. www.lastbdarchs.com





3. Individual license renewal forms will be mailed out in mid October, 2003. If you do not receive a renewal notice by December 1, please notify the Board. To avoid a late fee, your renewal form and fee must be received in the Board office or be postmarked by midnight December 31, 2003.

4. If you are moving be sure to notify the Board. You may do so by mail, email, or fax.

DISCIPLINARY ACTION

By consent order, the license of **Bruce J. Roberts** to practice architecture in Louisiana has been suspended for a period of six (6) months. Mr. Roberts did not obtain the required CEH and thus did not renew his license for the years 2001 and following; nonetheless, Mr. Roberts practiced architecture during this period. To renew his license, Mr. Roberts must first obtain the required number of CEH for the years 2000 and following (which the board estimated would take six months or longer), and Mr. Roberts may not practice architecture during this period. Upon obtaining the required CEH, Mr. Roberts may submit a renewal application to the board with satisfactory evidence that he has completed the required number of CEH. This submission will trigger a period of six months during which Mr. Roberts' license will be suspended, and Mr. Roberts will not be allowed to practice architecture until this six month period has expired.




WHEREAS, Dot and her husband, Albert, are the parents of two daughters, Kelly and Rodlynn; and


WHEREAS, Dot is and will be truly missed.







ARE UPDATE
from the NCARB website:

The National Council of Architectural Registration Boards implemented a \$35 rescheduling fee for Architect Registration Examination (ARE) candidates, *beginning July 1, 2003.*

This fee will be assessed each time a candidate makes any changes to his/her previously scheduled appointment. Candidates will be required to select their future appointment date at the time they notify the Prometric Candidate Services Call Center of their schedule change. The only acceptable form of payment for this fee will be by credit card.

Rescheduling an existing appointment must take place no later than 12:00 noon ET (Eastern Time) on the third business day prior to the candidate's scheduled appointment. Please note that Saturday is considered a business day.

If a candidate fails to arrive for his/her scheduled appointment or attempts to reschedule without giving the required notice, he/she will forfeit the entire test fee.

**Ron Blitch, Architect, FAIA, FACHA - appointed as Assistant Chair of
 A.R.E. for 2003**

Ron Blitch, Architect, FAIA, FACHA has been appointed by President Elect Robert A. Boynton, Architect, FAIA as the 2003 Assistant Chair of the Architectural Registration Examination of NCARB. Passage of NCARB's Architectural Registration Examination is the primary path to licensure in all U. S. states and territories, and the provinces of Canada. Ron has the opportunity to serve as Chair of the A.R.E. in 2004. Ron is President of Blitch/Knevel Architects in New Orleans.

Ron served on the Louisiana State Board of Architectural Examiners from 1993 to 2000 and was President in 2000. He has served on the Architectural Registration Examination Committee since 1995. He was a grader for the exam prior to the switch to a totally computerized exam in 1997, and has served on the ARE Construction Documents and Services Committee for the exam since 1997. Ron was coordinator of that committee from 2000 to 2002 and recently completed a year of service on the ARE Graphics 2 Committee.

Ron completed 12 years as Advisory Group Chair of the Design for Aging - Center of Excellence for AIA (1990-2002), and continues to be involved in the Design for Aging - Facilities Review program, with bi-annual exhibits and publications for AIA and AAHSA (American Association of Homes and Services for the Aging).

He was named a Fellow of the American Institute of Architects in 1999 and a Fellow of the American College of Healthcare Architects in 2001.
