The first meeting of the Louisiana State Board of Architectural Examiners was held at Gov. J. Y. Sanders' office on November 30, 1910.

215 architects had registered under Act 231, Sec. 5. In 1911, 138 renewed their licenses, 1 exam was given. Cost of renewals was \$5.00; exam cost was \$11.00

Robert E. Eddleman was hired on June 29, 2009 as part-time investigator to ensure that the Board's Laws/Rule and Regulations were being followed.
